- 2. Field Mechanics
 - a. Special Rules
 - i. 6-man and 9-man rules differences
 - 1. When you're working these levels of football, be sure to take some bespoke time in your pregame to go over the rules differences!
 - a. See Rules book pgs. 90-92
 - 2. **Don't be the crew** that throws an Ineligible Downfield Player in 6-man football; or throws a 7-2-5 Numbering Violation foul in 9-man football!
 - ii. Under-2-minute timing exception
 - 1. Are you alerting your crewmates when we reach the "under two" in the 2nd and 4th quarter?
 - 2. What is the option for penalties in this situation?
 - a. See Rule 3-4-7; p. 45
 - iii. PSK
 - 1. There are 5 requirements for a foul to be PSK. Do you know them? I'll help you out on this one!
 - 2. It is PSK when there is a foul by Team R and:
 - a. the foul occurs during a scrimmage kick play that isn't a try or FG;
 - b. the foul occurs during a scrimmage kick play in which the ball crosses the expanded neutral zone;
 - c. the foul occurs beyond the expanded neutral zone;
 - d. the foul occurs before the end of the kick;
 - e. and Team K will not be the next to put the ball in play.
 - 3. It's worth going over what makes a foul fall into the PSK special enforcement "bucket" as part of your pregame. (See Rule 2-16-2h; p. 32)

3. Officiating Philosophy

- a. Preventative Officiating
 - i. Preventative Officiating occurs from the very moment we take the field. We speak about this topic a ton, but what constitutes this vitally important part of our game?
 - ii. Here are a few examples:
 - 1. Diligently look for illegal equipment during the pregame warmups.
 - a. Fix it now and prevent stopping things later!
 - 2. Before every varsity game, watch film!
 - 3. See some snaps during warmups to help your eyes get ready to officiate.
 - 4. Do not allow a preventable foul on free kick downs.
 - 5. If a player's actions are close to a foul, speak with the player and communicate what you want to see or what "right looks like."
 - 6. Be situationally aware.
 - a. Anticipate a coach taking a timeout and inform them they can leave the coaching box to get your attention.
 - i. "Coach, even if we're down by the goal line, come get my attention and make sure we get that TO for you."
 - b. Inform the crew if you know a field goal, onside kick, or trick play is going to occur.
 - c. Know when a team might "go tempo."
 - i. Are you discussing Tempo every week in the pre-game?
 - d. Is the line to gain close?
 - e. Do we have "double stakes?"
 - 7. Communicate which official has goal line responsibility.
 - 8. Keep coaches informed regarding remining timeouts.
 - 9. Communicate whether the clock will run on the RFP or remain stopped until the snap.
