### RULE 5.8.0 – OUTSIDE COMPETITION

Rule 5.8.0, which pertains to outside competition, was taken out to the district meetings for discussion. The District's felt that the rule should be enforced as written.

### RULE 7.6.72 – PIN POINTS FOR TWO WRESTLERS

Associate Commissioner Wilson suggested that the following wording be added to clarify Rule 7.6.72:

Whenever two wrestlers from the same school wrestle a match, pin points will automatically be awarded to the winner, regardless of the outcome of the match.

### **GIRLS WRESTLING LETTER**

The WHSAA received a letter from a parent expressing his displeasure with females being allowed to wrestle. Associate Commissioner Wilson explained that as an Association, the WHSAA cannot deny a female the opportunity to participate in wrestling.

### SPORTSMANSHIP / EJECTION REPORT

Good sportsmanship numbers are comparable to those at this time last year and ejection numbers are down. The WHSAA will continue to encourage officials and school personnel to report acts of good sportsmanship.

### NFHS FUNDAMENTALS OF COACHING CLASS

The NFHS has updated its' Fundamental of Coaching Class. The new version will be taught at the summer coaches clinic.
