### COMBINATION AGREEMENT PROPOSAL DISCUSSION

Rule 3.1.3 – Combination Schools was discussed at length with the Board proposing the following change be taken out to the Districts as a first reading item:

3.1.32 When pursuing a combination school agreement, the petitioning school must consider combining with another school in their own district first, followed by the closest school geographically next. When a district school, or the one geographically closest, does not mutually agree to a combination, the next closest school should be considered. The commissioner reserves the right to recognize combination school agreements that have a historical significance to schools involved.

This documentation is to be submitted to the WHSAA office before the first date of competition of the season in which the team competes as a combined team.

Further points of discussion will include determining if all combinations should be with the same school if the activity is offered, whether the largest school must always be the host, determining if a stipulation should be made that schools may not combine and then go down a classification, and determining a cut-off date for submitting the Combination School Agreement form.

## FALL SEASON WRAP-UP

### STATE MARCHING BAND

Results from the State Marching Band Festival, held October 19<sup>th</sup> at the Casper Events Center, were presented.

### NFHS NETWORK

The WHSAA is continuing to work closely with the NFHS Network to provide video stream coverage of state culminating events in activities and athletics. There has already been an increase in the state events that have been covered as compared to past years. The NFHS Network is contracting with Wyoming companies to provide coverage.

### PRE-SCHEDULING MEETING

Commissioner Laird feels the pre-scheduling meeting held on October 30<sup>th</sup> was of great benefit and accomplished the intended goal.

### FORFEITS

Commissioner Laird asked for input from the Board concerning Rule 4.7.1, which states:

4.7.1 Any school violating a contract could be fined up to \$300, with money going to the offended school. Lack of payment would be cause for immediate suspension.

The Board felt the current rule does not adequately address the situation and feels penalties should be stiffer. The Handbook Committee, with recommendations from the WHSAA, will prepare a proposal for first reading consideration to take out to the next round of District meetings.

### EIGHT SEMESTER CONSIDERATIONS

The WHSAA received a request to review the Eight Semesters of Eligibility rule when taking into consideration students who are academically accelerated and wish to participate in activities.

# CASPER'S NEW SCHOOL

Casper is currently in the development stage of a new high school called CAPS – Center for Advanced Placement of Students. Commissioner Laird will be inviting the Principals and Activities Directors from Kelly Walsh and Natrona County and the CAPS Administration to attend the February Board of Director's meeting to discuss how the school's vision will work within the WHSAA rule structure.

## FOLLOW-UP TO H.E.M.'S CONFERENCE CHANGE REQUEST

The WHSAA has always allowed classifications to set their own conferences and will only get involved if a decision cannot be reached.
